RESPONSIBILITIES AND RELEASE FROM LIABILITY

Please read the following and sign below.

NORTH OF THE BORDER ADVENTURES LLC (Mezcalistas) acts solely as an agent for transportation, accommodations, and some meals. We assume no responsibility for any injury, delay, loss, or damage to persons or property caused by any persons, firm, corporation, or other legal entity providing services incidental to these tours.

Any expense incurred by delays or events beyond the control of NORTH OF THE BORDER ADVENTURES, such as weather, political instability, medical emergency, shall be borne by the participants.

The itinerary is subject to change due to local circumstances. NORTH OF THE BORDER ADVENTURES reserves the right to substitute accommodations and services of comparable value when necessary.

NORTH OF THE BORDER ADVENTURES reserves the right to cancel the trip before departure if deemed advisable. In the event of trip cancellation, liability will be limited to a refund of all funds received to date, minus non refundable expenses. Expenses incurred by the participant in preparation for the trip, such as airline tickets or vaccinations, are not the responsibility of NORTH OF THE BORDER ADVENTURES.

There are no refunds for unused portions of the trip. The trip is priced as a package and therefore credits are not given for services offered but not used.

You agree to have a valid passport in order to enter the country. NORTH OF THE BORDER ADVENTURES cannot accept responsibility if you are refused entry to a country due to incorrect documentation. You agree to have proper identification on your person at all times.

You agree to purchase evacuation insurance and provide NORTH OF THE BORDER ADVENTURES with policy number and provider's 800 number. If you choose not to secure this insurance you accept that these services may not be available to you or that you may be charged for them if they are deemed necessary to your present condition and will assume full responsibility for payment of any such services.

While traveling with NORTH OF THE BORDER ADVENTURES, you agree to accept the authority of the trip leader or local expert at all times.

NORTH OF THE BORDER ADVENTURES retains the right to accept or decline any member of the tour at any time.

NORTH OF THE BORDER ADVENTURES will not accept responsibility or liability for any traveler who breaks any law or regulation of any country visited.

In order to be informed and prepared for your tour, you agree to read all written information provided to you by NORTH OF THE BORDER ADVENTURES and ask for any clarifications before departure.

You are aware that we will be traveling in the Developing World where the standards of hygiene, safety, and timeliness are not the same as you experience at home. You are also aware that traveling with a group requires flexibility, compromise, and generosity on the part of each participant.

Guests must show proof of full vaccination to confirm their spot for all trips until further notice. We reserve the right to change our operating policies at any time in order to prioritize the safety and health of our guests as well as the inhabitants of the regions we travel to. To the fullest extent permitted by law, you on behalf of yourself, your heirs, legal and personal representatives, next of kin, including your spouse, successors and assigns (collectively, "Releasors") expressly RELEASE, WAIVE, FOREVER DISCHARGE AND COVENANT NOT TO SUE NORTH OF THE BORDER ADVENTURES, its owners, officers, employees, managers, shareholders, affiliated entities, agents, representatives, officers, directors, volunteers, guides, successors and assigns (collectively, "Releasees"), from and against any and all liability, claims, causes of action, demands, costs, damages, losses or suits of any and every kind which you now have or may later have against Releasees arising out of, relating to, or in connection with the travel services arranged through or provided by NORTH OF THE BORDER ADVENTURES, whether arising from Releasees' negligence or otherwise.
